ADULT/YOUTH DOUBLES SMACKDOWN TOURNAMENT RULES

1. This tournament is hosted by SoCal Bowling Enterprises and is open to all current California USBC members in good standing. Participants that do not have current USBC membership may enter with a \$5 participation fee. All youth are eligible for scholarships. Bowlers must be certified USBC members in order to receive USBC awards.
 2. **QUALIFYING:** Santa Clarita Lanes, 21615 Soledad Canyon Road, Saugus, CA 91350, 661-254-0540 and Linbrook Bowl, 201 S. Brookhurst St, Anaheim 92804, 714-774-2253 on **June 2, 2018 at 1pm & 4pm**. Entries close on June 2, 2018 at 3:30pm or when squads are full. **FINALS:** Winnetka Bowl, 20122 Vanowen St, Winnetka, (818) 340-5190 on **June 3, 2018 at 10am**.
 4. **FORMAT:** Each team must consist of one adult member and one youth member. **QUALIFYING:** Three (3) games on the same pair of lanes. The top four (4) teams from each division and location will qualify (total pinfall plus handicap if applicable) to the Finals to be held on Sunday, June 3. **FINALS:** The format is a two game baker style single game elimination bracket per division. **Teams must verify their attendance on Saturday, June 2 by 7pm.**
 5. **DIVISIONS:** Scratch and Handicap. Handicap is 80% of 230. A minimum of 8 entries is required per division. If less than 8 entries are received the entries will automatically move to the other division.
 6. **Teams may enter twice with the same partner, but can only qualify once.**
 7. **YOUTH ENTERING AVERAGES:** All participants must have an established CA USBC average. USBC Rule 319c will apply.

- ADULT ENTERING AVERAGES:** All participants must have an established CA USBC average. USBC Rule 319c will apply.
- A. Highest USBC certified 2016-17 avg (min 21 games), If none,
 - B. Highest USBC certified current avg as of tourn. date (min 15 games), league sheet provided, If none,
 - C. Highest USBC certified 2015-16 avg (min 21 games), If none,
 - D. Entering average: 230
- Bowlers are responsible for verifying their own averages. **If a "sport" league average is the bowler's only verifiable average, then it will be adjusted per the USBC sport chart to determine the correct entering average.** USBC rules 319a2, 319d and 319e will be waived.
8. **DRESS CODE: No alcoholic, tobacco, sexual or profane advertisement on any attire or equipment. NO tank tops, halter tops, short-shorts, sweats, spandex, "cut-offs", or hats of any kind allowed.**
 9. Replacements for original entrants may be made providing the replacement meets eligibility and average requirements. A replacement must bowl under their own name at the time the event is scheduled.
 10. **ENTRY FEE:** \$30 per person (\$18 lineage + \$6 exp. + \$6 scholarship). **Make checks payable to SOCAL BOWLING ENTERPRISES.** Write "Smackdown" in memo. Any returned checks must be paid in cash or money order on-site plus a \$35 penalty fee. **Mail entries and fees to:** Smackdown, 3415 Duchess Ln, Long Beach, CA 90815. **DO NOT MAIL entries after MAY 29 – Bring them on-site for processing.**
 11. All awards and scholarship fees collected shall be returned 100%. Scholarships will be awarded to the top 8 finalists per division. Scholarships will be held with the USBC SMART program under account #13142, (800) 514-2695 x8292.
 12. Food and drinks in the bowlers' area are prohibited. Only bowlers and tournament workers are allowed in the bowler's area. Non-alcoholic beverages and food must be kept on the back counter only. **Alcohol may only be consumed by spectators in the bar or on the concourse area only.**
 13. Designated funds will be paid accordingly within 30 days upon completion of the tournament, except when USBC nationals has authorized delay in payment, pending settlement of any claim or protest which effects position standings.
 14. Bowlers must check-in one hour prior to scheduled squad time and must show proof of current USBC membership.
 15. Bowlers arriving late shall begin competition with the frame currently being bowled. Missed frames shall be credited with a zero and may not be made-up. Bowlers not present to bowl when it's their turn will be credited with a zero for that frame.
 16. In the event a bowler cannot finish their series, zero pins will be scored the remaining frames.
 17. This tournament is certified by USBC.
 18. One lane courtesy only. Pacers are not allowed.
 19. The Tournament Director shall be the authority to interpret USBC rules, tournament rules, policies and procedures in deciding disputes. If deemed necessary, the Tournament Director shall consult with the CUSBC Youth Committee.
 20. An appeal or protest of a decision involving eligibility or playing rules must be filed in writing with the Tournament Director and the USBC before tournament prizes or scholarships are paid. The decision of USBC is final and binding on all involved parties. Any violation of tournament rules is cause for disqualification, loss of entry fee, forfeit of all scholarship awards and possible suspension from USBC membership.
 21. Protests must be made in writing within 72 hours of the time of bowling to Tournament Manager. Disputes occurring on the lanes are decided by the tournament official in charge. USBC Rule 329(a)2 and 329(b)2 will apply.
 22. **A 0% TOLERANCE RULE IS IN EFFECT FOR ANY DISRUPTIVE ACTIONS BY TOURNAMENT PARTICIPANTS AND SPECTATORS, SO PLEASE DISPLAY YOUR OUTSTANDING PROFESSIONALISM AND SPORTSMANSHIP AT ALL TIMES.** This includes the use of profanity and/or abuse of equipment.
 23. ANY AND ALL RULES NOT COVERED IN THE ABOVE SHALL BE GOVERNED BY UNITED STATES BOWLING CONGRESS RULES.
